**APPEARANCE RELEASE**

For good and valuable consideration, receipt of which is hereby acknowledged, I the undersigned, do hereby grant to \_\_\_\_\_ (“Producer”) the irrevocable right and license to use my name and biographical material concerning me, and all rights in connection with the short film produced for entry in the iReport Film Festival (the “Film”) made by Producer of my likeness, poses, acts and appearances, and any sound recordings made by Producer in connection with the Film (as well as any quotes I may give) (“My Likeness”).

I, the undersigned, agree that the Film shall be owned by Producer, and the Producer, its successors, assigns and licensees, including, without limitation, Cable News Network, Inc. and its designees and licensees (collectively, “Licensed Parties”) shall have the irrevocable and perpetual right, worldwide, in any manner and in any media to use and exploit the films, photographs, and recordings made of My Likeness in connection with the Film in such manner and to such extent they desire in their sole discretion.

I further release Licensed Parties from any and all claims that I have or might have by virtue of or arising out of the production, exhibition, distribution, promotion and/or advertising of the Film, including without limitation, any claim for defamation, slander or invasion of privacy or infringement of rights of publicity. The results and proceeds of the Film shall be deemed a “work made for hire,” as such term is defined under the copyright laws of the United States, with Producer as the author and exclusive owner thereof.

Nothing herein will constitute any obligation of the Licensed Parties to make any use, or prominent use, of any of the rights set forth herein.

**LOCATION AGREEMENT**

Your signature in the space provided below as owner or agent will confirm the following agreement between \_\_\_\_\_ (“you”) and \_\_\_\_\_ [participant’s name] (“Producer”) regarding Producer’s use of the Premises described below in connection with the short film produced for entry in the iReport Film Festival (the “Film”). This letter sets forth the entire understanding between you and Producer and may not be altered except by another written agreement signed by both you and Producer. For good and valuable consideration, the receipt and adequacy of which you hereby acknowledge, the parties agree as follows:

1. The "Premises" as used herein refers to the premises located at: \_\_\_\_\_ including the grounds at such address and all buildings and other structures located thereon, together with the trademarks and logos of the premises as depicted in the Film.
2. You hereby represent and warrant that: (i) you are the owner or the agent for the owner of the Premises and you have the right and authority to make and enter into this Agreement and to grant Producer the rights set forth herein; (ii) it is not necessary for Producer to obtain the consent or permission of, or to pay any amounts to, any person, corporation or entity in order to enable Producer to make use of the rights set forth herein; and (iii) you are subject to no obligation or disability and there are no outstanding contracts or commitments of any kind which conflict with this Agreement or the rights granted to Producer hereunder.
3. Producer shall be the sole and exclusive owner of all rights of every nature, including all copyrights, in and to all films, photographs and recordings made on or of the Premises, in perpetuity throughout the universe. You hereby grant to Producer and its successors, assigns and licensees, including, without limitation, Cable News Network, Inc. and their respective designees and licensees, the irrevocable and perpetual royalty-free right, worldwide, in any manner and in any media to use and exploit the films, photographs, and recordings made of or on the Premises in connection with the Film in such manner and to such extent they desire in their sole discretion.
4. Producer shall have the right to transfer or assign its rights or obligations pursuant to this Agreement to any other person, corporation or entity and shall be relieved of its obligations to you hereunder to the extent that such obligations are assumed by such person, corporation or entity.
5. You acknowledge and agree that no further payment is due you in connection with the rights granted hereunder.
6. Your rights and remedies in the event of any breach of this Agreement by Producer will be limited to the right, if any, to seek to recover money damages in an action at law and in no event will you be entitled to terminate this Agreement or to seek injunctive or other equitable relief.

**VIDEOGRAPHER RELEASE**

For good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, I agree as follows:

1. I shall furnish my videography services to \_\_\_\_\_ (“Producer”) in connection with the short film produced for entry in the iReport Film Festival (the “Film”).

2. Any film, video or other recordings (the “Property”) created or developed by me for Producer in connection with the Film shall be a “work-made-for-hire” (as that term is used in the Copyright Law of the United States). As between Producer and me, Producer is, therefore, to be deemed the owner of all copyrights in and to the Property, and shall have the right to copyright the same in its name or the name of its nominee. In the event that the Property, or any portion thereof, is for any reason deemed not to have been a work-made-for-hire, I hereby grant, assign and transfer to Producer any and all right, title and interest I may have in and to such Property, including the copyright.

3. Producer and its licensees, successors and assigns, including, without limitation, Cable News Network, Inc. and their respective designees and licensees (hereinafter collectively referred to as the “Producer Parties”), shall have the irrevocable and perpetual, royalty-free right, worldwide, in any manner and in any media to use and exploit the films, photographs, and recordings made of the Property in connection with the Film in such manner and to such extent they desire in their sole discretion. Without limiting the foregoing I hereby waive any and all claims that I may now or hereafter have in any jurisdiction to so-called “moral rights” or “droits morals”. I agree to execute such further instruments as Producer may from time to time deem necessary or desirable to evidence, establish, maintain and protect Producer’s ownership of the Property, and all other right, title and interest therein. If I am unable or unwilling to perform such acts, then I hereby appoint Producer as my attorney-in-fact with full power and authority to execute any and all documents and take such other action as is necessary to accomplish the foregoing. The foregoing power of attorney shall be coupled with an interest and be irrevocable.

4. No materials incorporating the Property need be submitted to me for any further approval and the Producer Parties shall be without liability to me for any distortion or illusionary effect resulting from the publication or other use of the Property.

5. I shall keep the terms of this agreement confidential and any information Producer provides to me which is identified as confidential, including, without limitation, the compensation paid to me, and I shall not disclose any such terms without Producer’s prior written permission.

6. I warrant and represent that I have the full right and power to enter into this agreement and to grant the rights granted hereunder, and that this agreement does not in any way conflict with any existing commitment on my part.

7. Nothing herein will constitute any obligation of the Producer Parties to make any use of any of the rights set forth herein.

8. I agree that no further payment is due me in connection with the rights granted hereunder and that this agreement supersedes all prior negotiations between myself and Producer relating to the rights granted herein and no provision of this agreement can be modified by any other instrument, invoice, purchase order or other document unless in writing and signed by both parties hereto.

## PROPERTY RELEASE

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned ("Licensor") hereby agrees as follows:

4. Licensor warrants and represents that Licensor has the full right and power to grant the rights herein granted and that this license does not in any way conflict with any existing commitment on Licensor's part. Licensor further represents and warrants (i) that Licensor is the exclusive and sole owner of the Property or that Licensor is authorized to grant the rights to make the agreements set forth herein with respect to the use thereof (including, without limitation, with respect to the use and recording of any third party logos appearing thereon or any third party logos obscured thereon, required in connection with the Licensed Parties' depiction and use of the Property), with no further payment of any kind to Licensor or any third party, (ii) that the proper exercise by the Licensed Parties of the rights granted hereunder will not violate the rights of any third party, including, without limitation, the copyright, trademark and other proprietary rights in and to the Property (including, without limitation, with respect to the logos appearing thereon or obscured thereon), and (iii) that the requisite permission to use any name or logo which is embodied in the Property (including any logos appearing thereon or obscured thereon) has been properly secured by Licensor.
5. Licensor hereby (i) expressly releases, discharges and waives all claims, demands, losses and liabilities of any nature which may arise from, and (ii) covenants not to make any claims against, the Licensed Parties as a result of, any and all loss or injury caused by or occurring as a result of the exploitation of the rights granted hereunder. In addition, Licensor shall defend, indemnify and hold the Licensed Parties harmless from and against all claims, losses, costs, expenses, settlements, demands, and liabilities of every kind (including reasonable attorneys' fees) arising out of or incurred by reason of the Licensed Parties' use of the Property as set forth herein or the breach or alleged breach of any representation, warranty, covenant, agreement, or undertaking Licensor has made herein.

6. Nothing herein will constitute any obligation of the Licensed Parties to make any use, or prominent use, of any of the rights set forth herein. Licensor agrees that this license supersedes all prior negotiations and understandings between Licensor and the Licensed Parties relating to the rights granted herein.
