On September 18, 2008 I responded to 4937 Hopespring Drive in the Chickasaw Park Subdivision in reference to a suspicious incident.

Upon arrival I made contact with the victim/reporter, Cynthia M. Anthony, who advised of the following: At approximately 0010 hours on September 18, 2008, Cynthia heard noises coming from the front area of her home. It sounded like rocks were hitting the front bedroom window and the garage door. Cynthia advised she observed via her surveillance camera, a large group of people (approximately 14 people) standing in the middle of her front yard. Cynthia advised she could not describe or identify anyone from the surveillance video because it was to dark. Cynthia then called 911.

I did an area check around the residence and found four coins around the front window (three pennies & one dime) and two coins in front of the garage (two nickels). It appeared the suspects (demonstrator) threw coins at Cynthia's home.

Coins were submitted into OCSO evidence.
