Narrative														

On 1/22/09, I was dispatched to 4937 Hopespring Dr in reference to a endangered missing person. Upon arrival I met with the witness, Cynthia Anthony and the reporter, Brad Conway. Cynthia Anthony is the wife of missing person, George A. Anthony.

Cynthia stated she last saw George at 1030 hours on 01/22/08 at the above location. She stated he was leaving for a job interview. Cynthia stated he left wearing a long sleeve light blue dress shirt and black dress pants. Cynthia stated George has been upset and depressed about the death of his granddaughter, Caylee Marie. She stated she asked George yesterday to pick out some jewelry for Caylee for her funeral. Cynthia said she believes this might have made him even more depressed. She stated today (01/22/08) she noticed George did not show up for several meetings throughout the day. Cynthia said she called him but never received a phone call back. She stated she started to become worried about George because he cancelled a meeting he had with a friend in Lakeland, Florida. Cynthia stated she called other friends and family members but no one heard from him either. She said she tried to make several more attempts to call or text him with no success. Cynthia said she checked George's nightstand to see if his medication was missing and it was. George takes medicine for his [REDACTED] [REDACTED] p and medication for [REDACTED]. The bottles should have been at last two weeks full of medication. Cynthia said she also noticed a picture of herself and her daughter missing from the house. She did not see any of George's clothing or other personal belongings missing from their residence.

I entered George into Teletype under 1 BOLO 141 as a missing endangered person.

Cynthia stated George left in his black 2007 Chevy HHR. The vehicle has four doors and lightly tinted windows. The tag on the vehicle should be a Florida tag of 810 ILT. She described George as a white male about 5'9, 170lbs, with white hair and brown eyes. Cynthia stated around 2247 hours (01/22/08) George began to send her and other friends text messages via cell phones. The text messages George sent stated he did not want to live anymore and that he wanted to be with Caylee. George text he wanted to be left alone and wanted to make sure Caylee was in God's arms. George would not text where he was located. Cynthia stated other then the locations

she had friends check, she does not know where George might have gone.

Orange County Sheriff's Office was able to track the GPS on George's cell phone to an area in Daytona Beach called Bethune Pointe Park. Daytona Beach PD and a few Orange County Felony units went to the location to try and locate George.

George was found at approximately 0157 hours in Daytona Beach at the Hawaii Motel in good health. George was transported to Halifax hospital [REDACTED]. The BOLO was cancelled and George was taken out of Teletype as missing.
