## SUBPOENA AD TESTIFICANDUM

**NOTING** that the Prosecutor of the Special Court wishes to call you, **Naomi Campbell**, as a fact witness in the case of the *Prosecutor v*. Charles Ghankay Taylor;

**NOTING** that your legal representative, Mr. Gideon Benaim, has communicated to the Registrar of the Special Court that he is instructed to accept service of a subpoena;

PURSUANT to Rule 54 of the Rules of Procedure and Evidence of the Special Court ("Rules");

HEREBY ORDERS YOU to appear as a witness in the case of Prosecutor v. Charles Ghankay Taylor on Thursday, 29 July 2010 at 9:00 a.m., or to show good cause why you cannot comply with this subpoena;

**NOTING** that wilful failure to comply with the terms of this subpoena constitutes contempt of the Special Court pursuant to Rule 77 of the Rules. Should you fail to comply, the Trial Chamber may deal with the matter summarily itself, refer the matter to the appropriate authorities of Sierra Leone or, if there are sufficient grounds to proceed against you for contempt, issue an order in lieu of an indictment and direct independent counsel to prosecute the matter. If you are convicted for contempt of the Special Court you may be imprisoned for up to seven (7) years or fined up to two (2) million leones, or both;

### HEREBY INFORMS YOU that:

- 1. The address of the Special Court, sitting at The Hague, is: Dokter van der Stamstraat 1, 2265 BC, Leidschendam, Netherlands;
- 2. The hearing date at which your presence is required is subject to change and this subpoena remains in force notwithstanding any change to the hearing date. You will be informed about any change to the hearing date through the Registry of the Special Court;
- 3. All necessary measures will be taken by the Witness and Victims Section of the Registry of the Special Court for your travel, appearance to testify, and accommodation, and all necessary costs incurred by these arrangements shall be borne by the Special Court;

**REQUESTS** the Registrar of the Special Court to serve the subpoena on the legal representative of Ms. Naomi Campbell, Mr. Gideon Benaim, who has notified the Registrar of the Special Court that he is instructed to accept service of a subpoena on Ms. Naomi Campbell's behalf, at his office in London: Schillings, 41 Bedford Square, London WC1B 3HX, United Kingdom, and to take any further necessary measures to have this subpoena served and executed, seeking the assistance of authorised representatives of the Government of the United Kingdom where appropriate, and to ensure that, you, Naomi Campbell, appear at the time and place indicated above.
