

CELTICS COWENS CAMPS WAIVER, RELEASE AND ASSUMPTION OF RISK FORM

CampCo ABC, LLC AND ALL SUBSIDIARY INTERESTS d.b.a. CELTICS COWENS CAMPS

In consideration of my participation in the Celtics Cowens Camps at the Celtics Training Facility in Waltham, MA, The University Sports Complex in Hanover, MA, or Reebok HQ in Canton, MA, I hereby voluntarily waive, release and discharge any and all actions, causes of action or claims for personal injury, death or property damage which I may have or which may subsequently accrue to me as a result of my participation in such activities.

This release discharges and indemnifies CampCo ABC, LLC, Banner Seventeen, LLC (d/b/a the Boston Celtics), the National Basketball Association and its Member Teams, NBA Properties, Inc. and their respective officers, directors, unit holders, shareholders, agents, employees, parents, subsidiaries, affiliates, successors and assigns harmless from and against any and all actions, courses of actions, claims, demands, liabilities, losses, damages, costs and expenses (including reasonable attorney’s fees) arising out of my participation in such activities, even though the liability may arise out of negligence on the part of the entities or persons mentioned above, or otherwise.

I understand that I could be injured while participating in camp activities. I also certify that I am in good condition and am able to safely participate in camp activities, while playing, assisting or otherwise engaging in the sport of basketball as an active participant, assistant or spectator during such special events for which I have registered for.

I assume full responsibility for and risk of personal injury, death and property damage resulting from my participation in such camp activities, and I release and hold harmless the entities and persons named above who might otherwise be liable to me for damages.

I hereby grant CampCo ABC, LLC, Banner Seventeen, LLC (d/b/a the Boston Celtics), the National Basketball Association and its Member Teams, NBA Properties, Inc. the following irrevocable rights in connection with any and all photographs taken of me:

- (a) to use, re-use, publish, and re-publish, without my prior approval, any and all photographs taken of me, in whole or in part, individually or in conjunction with other photographs or images, modified or altered, in any medium, manner or form and for any purpose whatsoever, including, without limitation, all promotional, trade and advertising uses;
- (b) to use my name in connection therewith, if it so desires; and

I hereby waive any right to any compensation arising from or related to the use of such photographs. This release shall inure to the benefit of the assigns, licensees and legal representatives of CampCo ABC, LLC, Banner Seventeen, LLC (d/b/a the Boston Celtics), the National Basketball Association and its Member Teams, and NBA Properties, Inc.

I also understand and agree that this waiver, release and assumption of risk are binding on my heirs and assigns.
