COMMITTEE DESCRIPTIONS

WALKING SCORERS Serious golfer wanted! This committee needs the most volunteers! Approximately 56 walking scorers are needed each of the six days of competition. Walking Scorers must be able to walk 18 holes. Volunteers in this committee will be in charge with keeping track of three players' scores on the Palm Pilot. Must be knowledgeable golfers and no carts will be used by Walking Scorers. Training will be provided.

STANDARD BEARERS **DURING THE FINAL 3 ROUNDS (SAT-SUN-MONDAY ONLY) NEED A MINIMUM OF 52 PEOPLE A DAY. THIS PERSON HOLDS THE SCORING SIGN AND WALKS WITH THE GROUP.**

THE GOLF CHANNEL

Must be able to work the final three rounds Saturday – Monday. This committee needs 28 volunteers per day, Saturday, Sunday and Monday. You will be mobile, following a group or leaders or in a set position, holding a lightweight microphone. Advance training will be provided.

MARSHALS

A few marshals are needed to provide gallery control for the tournament and to staff the practice facility for the professionals. Marshals/ spotters are needed during the tournament rounds, Wednesday – Monday.

SHUTTLE CARTS

Volunteers are needed to transport volunteers to their assigned holes and players to and from the driving range. Shuttle carts will also be needed for scorecard running and delivering daily lunches to the marshals on course. This committee will work Sunday, Monday and Tuesday practice rounds for shuttles on the course and Wednesday – Sunday of Tournament Week.
